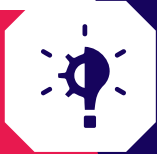

"Lead what matters most."

Identify high-leverage activities vs. distraction traps
Use the Leadership Leverage Ladder™
Realign priorities for fast performance ROI

WEEK 3

Decision Velocity

"Upgrade your leadership engine."

Uncover decision friction and bottlenecks
Install fast/focused decision frameworks
Clarify decision rights across teams

WEEK 4

Performance Conversations that Shift Behaviour

Strategy in Motion

“Make your strategy visible and actionable.”

Audit current strategy execution
Use the DLPA 3H Planning Canvas (Horizon Now, Next, Beyond)
Set up execution cadence for the next 90 days

WEEK 6

Team Energy & Influence

“Lift the energy that drives execution.”

Identify drains and drivers in your team dynamics
Triage low-impact meetings and touchpoints
Create a culture of uplift and ownership

WEEK 7

Resolve & Momentum

“Hard calls. Big moves.”

Build resolve + executive discipline habits

WEEK 8

Results & Reset

“Consolidate gains. Lock in change.”

Capture and present \$100K value outcomes
Final team reflection + forward strategy
Set post-program accountability for sustainability

Post-Program Options (Add-On)

Shadowing & coaching of second-tier leaders
